

ORDINANCE

No. 213

An Ordinance of the Code of Ordinances of the Borough of Honey Brook Amending Chapter 15, Section 304 to modify where Parking is Prohibited on Firehouse Lane, James Street, Park Street, Railroad Avenue and South Walnut Street within the Borough.

WHEREAS, Honey Brook Borough Council desires to modify the Code of Ordinances, Part 3 of Chapter 15, Section 304 in connection with the ability to park motor vehicles on Firehouse Lane, James Street, Park Street, Railroad Avenue and South Walnut Street within the Borough.

NOW THEREFORE, Honey Brook Borough Council hereby ENACTS and ORDAINS as follows:

1. The code of Ordinances, Part 3 of Chapter 15, Section 304.1 is hereby modified by deleting the references to prohibiting the parking of vehicles at all times on Park Street: (i) on the North side between Walnut Street to Pine Street and (ii) on both sides between Pine Street to the East Borough Line and inserting the following in their place:

<u>Street</u>	<u>Side</u>	<u>Between</u>
Park Street	Both	Walnut Street to East Borough Line

2. The code of Ordinances, Part 3 of Chapter 15, Section 304.1 is hereby modified by inserting the following in the list of locations where parking shall be prohibited

<u>Street</u>	<u>Side</u>	<u>Between</u>
Firehouse Lane	Both	Route 10 to the point which is 525 feet eastward from the centerline of the intersection of Route 10 and Firehouse Lane
James Street	North	Maple Street to Walnut Street
Railroad Avenue	East	Firehouse Lane to the point which is 245 feet northward from the centerline of the intersection of Railroad Avenue and Firehouse Lane

3. The code of Ordinances, Part 3 of Chapter 15, Section 304.1 is hereby modified by deleting the references to prohibiting the parking of vehicles at all times on Walnut Street: (i) on both sides between the Borough Line to Maple Street (ii) on the West side between Maple Street to Park Street; (iii) on the East side between Park Street North to 979 Walnut Street, and (iv) on both sides between 979 Walnut Street to Route 322 and inserting the following in their place:


Street Side Between
Walnut Street Both East Borough Line to West Borough Line

4. The code of Ordinances, Part 3 of Chapter 15, Section 304.1 is hereby modified by deleting the reference to prohibiting the parking of vehicles at all times on the West side of Maple Street between Walnut Street to Firehouse Lane and inserting the following in its place:

Street Side Between
Maple West Walnut Street to Park Street

5. All other provisions in Chapter 15, Part 3, Section 304 and all other provisions in Chapter 15, Part 3 shall remain unmodified and in full force and effect.


6. This Ordinance shall become effective upon enactment of Borough Council and approval by the Mayor.
